EAI to raise \$21.65 from underwriting unexercised options

Ellerston Asian Investments (EAI/EAIO) options expired at 5pm (AEDT) Thursday, 28 February 2019. During February, a total of 15.93m options were exercised at a price of \$1.00. From the 68.98m options issued by the Company as part of the IPO, 44.7m remained outstanding at the month end disclosure. Under normal practices these options were set to expire with no value. On Wednesday 27 February 2019, EAI announced the intention to undertake a partial underwriting from the pool of unexercised options at expiration. EAI has since entered into an agreement to underwrite up to approximately 21.65m of the EAIO at an exercise price of \$1.00.

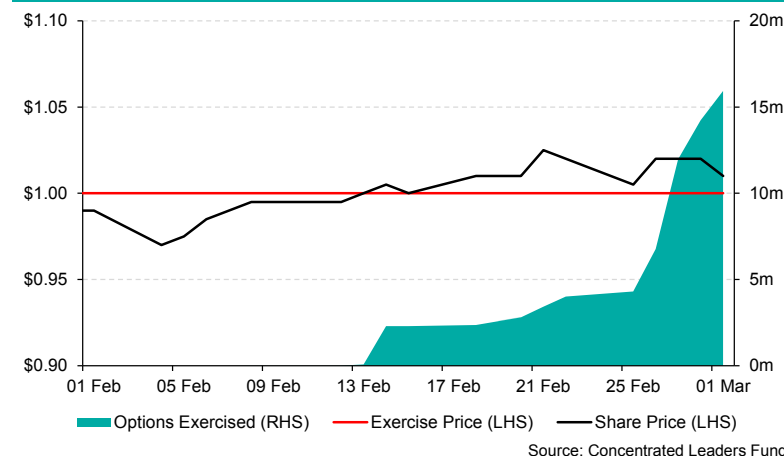
The Board provided 4 points on why a larger capital base will benefit existing shareholders:

1. Lower fixed costs per share
2. Improved trading liquidity
3. Provide further scale to invest in long term investment opportunities and increased Company relevance in the market
4. Increase and diversify the investor base and share registry

The beliefs of the board are valid. Costs incurred in building and maintaining an international focused portfolio are generally more costly compared to a domestic equity mandate. Reducing fixed costs per share will seek to benefit shareholders in the long term. A greater shareholder base will seek to benefit shareholders by providing a greater level of trading liquidity. These factors along with the increased portfolio size are seen to help reduce the NTA trading discounts of LICs.

EAI is expected to announce any option shortfall and options issued from the underwriting on or around 8 March 2019. All fees will be paid for by the management company.

EAI dividend date change

Following the announcement of the option underwriting, EAI has advised a change in the previously declared dividend date. This is to ensure that the underwritten options will be able to be eligible for the dividend of 1cps. However, the DRP will no longer be available under the revised timetable.

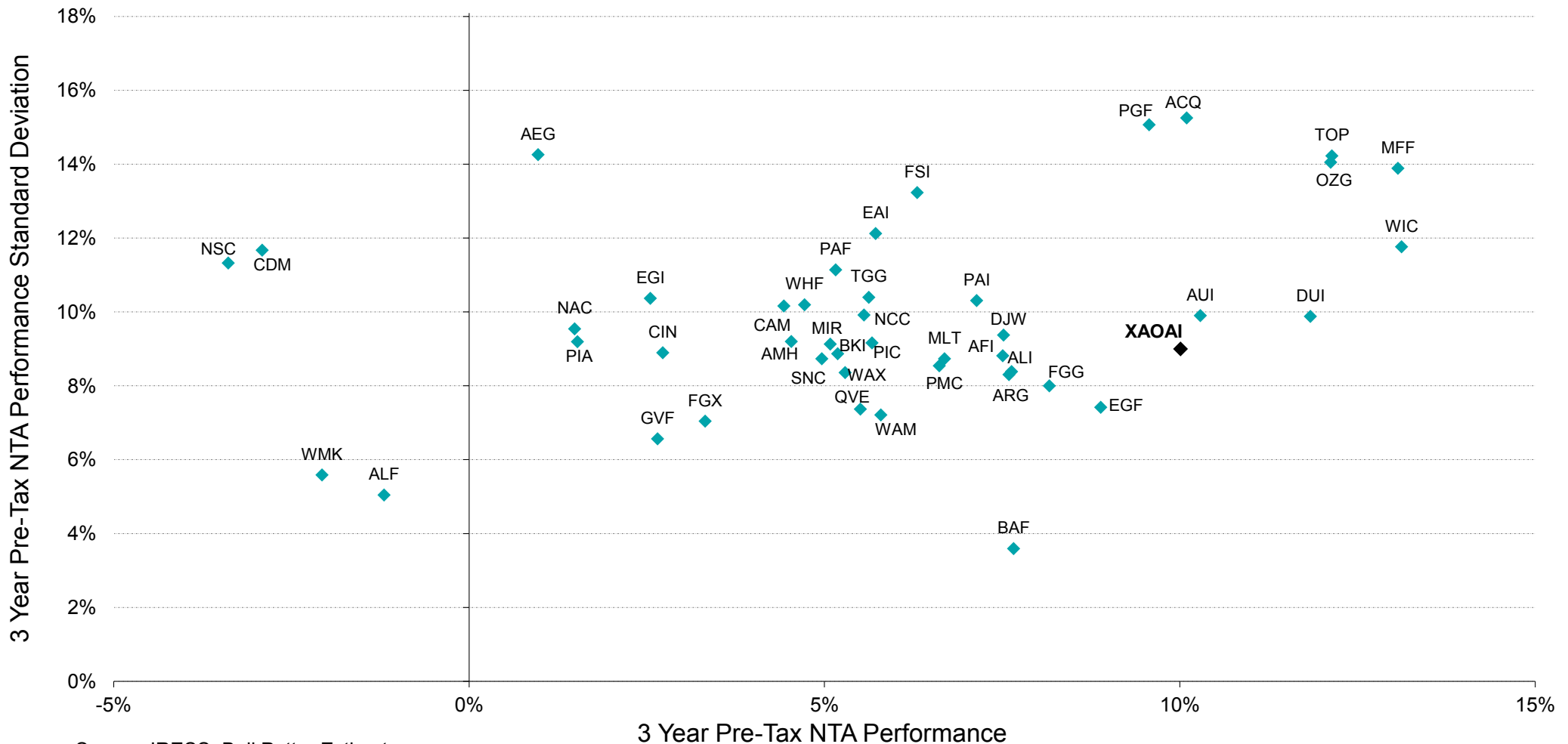

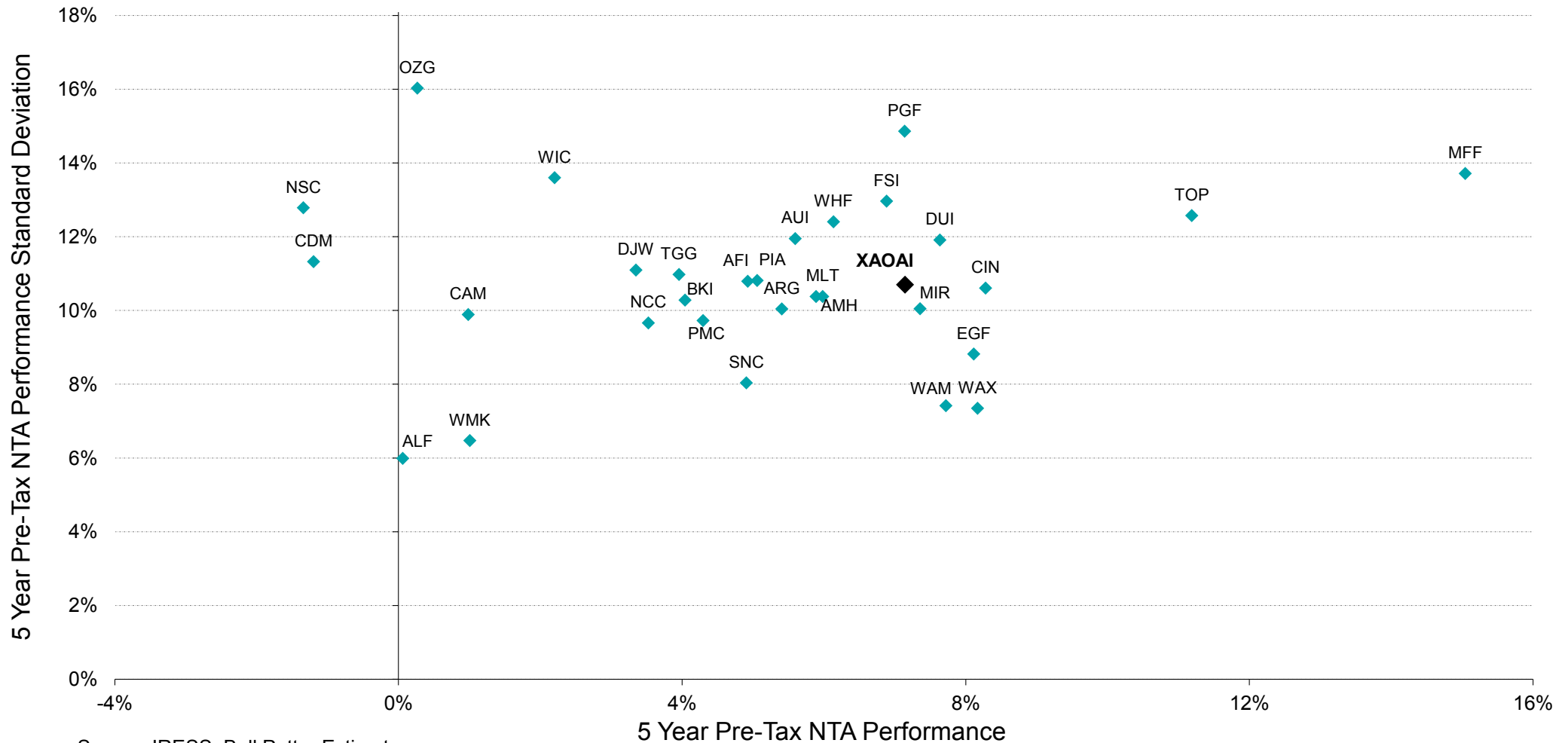
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

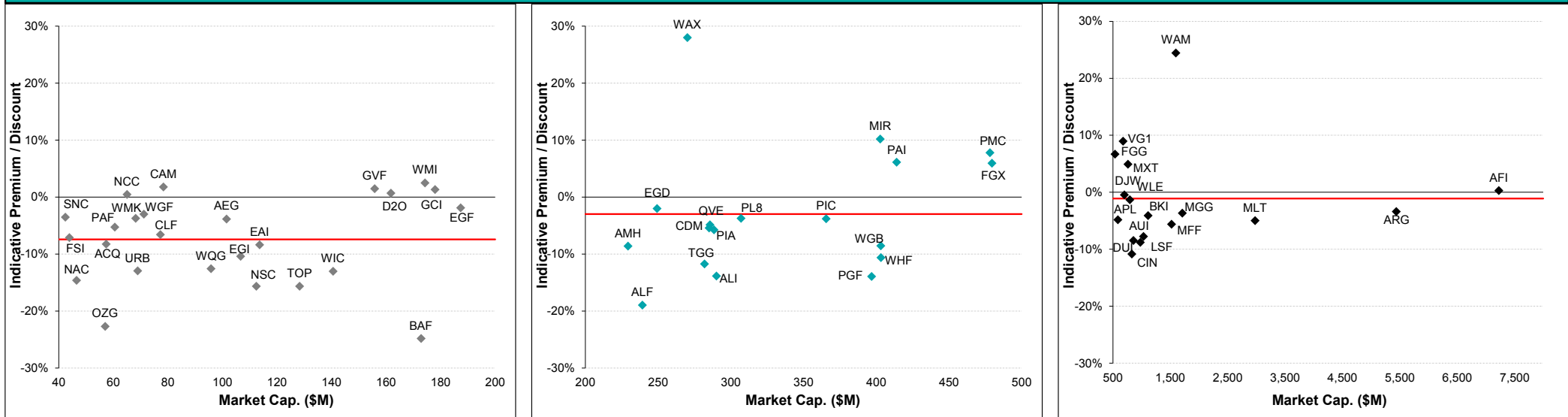

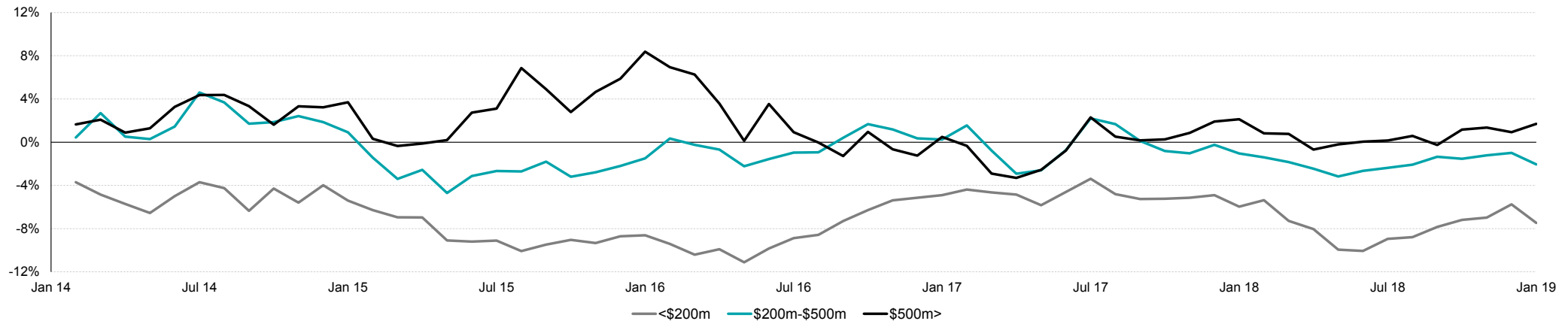

Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



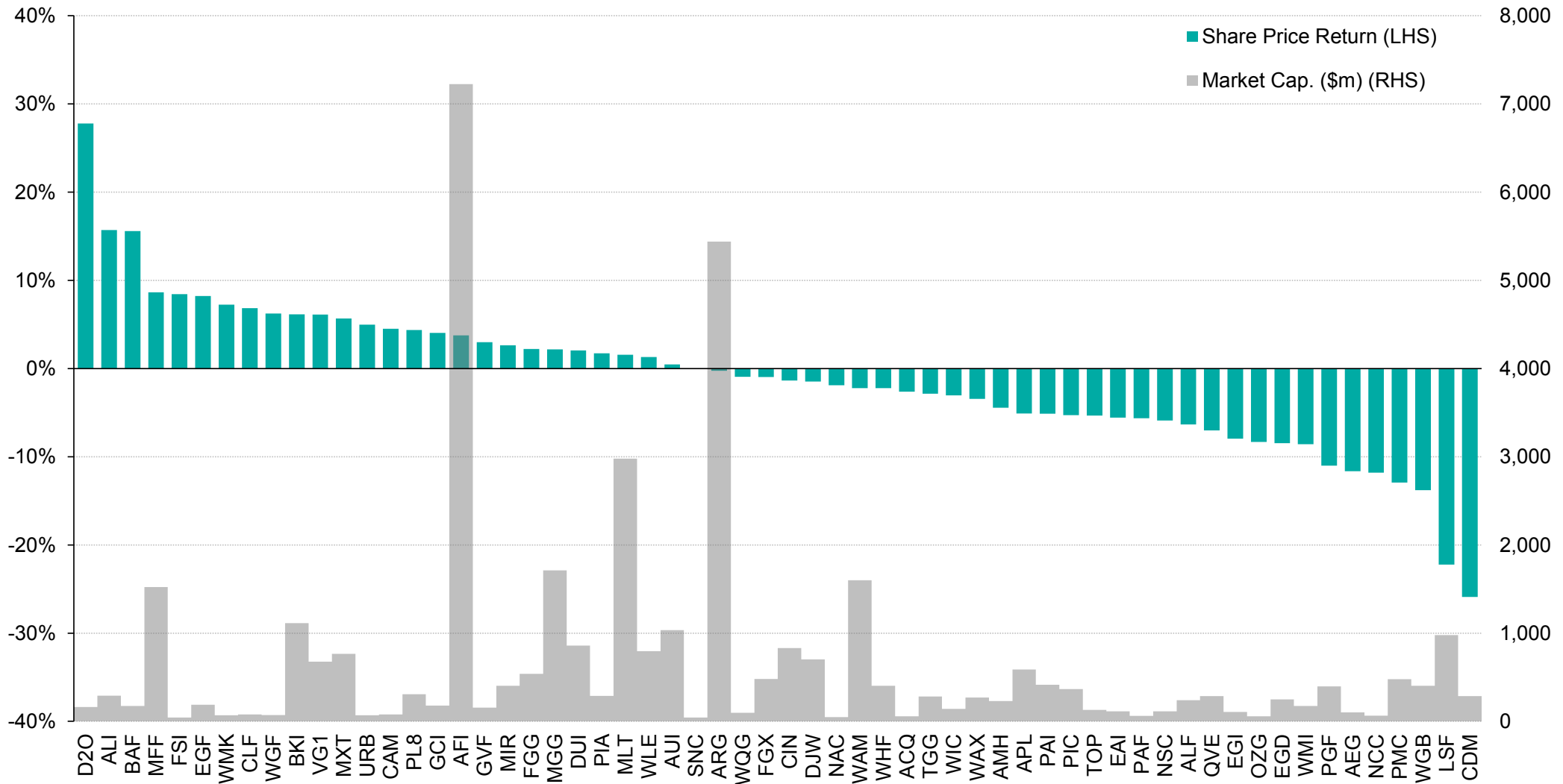
