WLE & CYA merger implemented

The Federal Court of Australia approved the merger between **WAM Leaders (WLE)** and **Century Australia Investments (CYA)** through a scheme of arrangement on 20 February 2019. WLE acquired 100% of the CYA shares on a pre-tax NTA basis. Under the terms, CYA shareholders received 0.834 new WLE shares for each CYA share held. CYA was removed from trading as of Wednesday, 6 March 2019. 78.62m shares have been issued in WLE under the scheme. As at 8 March 2019, WLE has a market capitalisation of \$880.6m.

WLE is a LIC focused on investments within the S&P/ASX 200 Index. WLE's investment objective is to deliver investors a rising stream of fully franked dividends, provide capital growth and preserve capital. WLE achieves this by combining two different investment strategies – a Research Driven strategy, which aims to identify micro and macro-economic trends and under research companies, and Market Driven strategy, which targets relatively short-term arbitrage and mispricing.

Figure 1: WLE equity portfolio composition by market cap

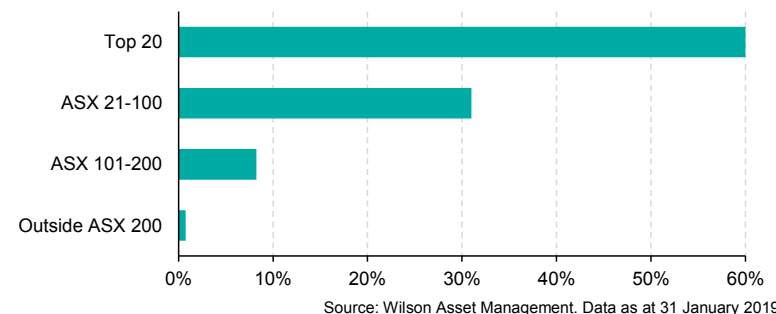


Figure 2: WLE share price performance return

MGG unit purchase plan raises \$277m

Magellan Global Trust (MGG) announced on Friday 8 March 2019 that almost 50% of unitholders participated in the unit purchase plan announced 29 January. Applications from for than 21,000 unitholders totalling ~\$277m were received as at Wednesday 6 March 2019, the offer close date. The offer provided an opportunity for eligible unitholders to acquire up to \$15,000 of new units at a 5% discount to the NAV as at 28 January 2019, declared at \$1.5327. New units will be issued on 13 March 2019 and will be entitled to the \$0.03 per unit distribution for the 6 months ending 30 June 2019.

Magellan Financial Group (MFG) will pay MGG approximately \$14.6m in order to minimise the dilution of the offer given the offer price was conducted at a 5% discount to NAV. MFG is the parent company of Magellan Asset Management, the responsible entity and investment manager of MGG. After the issuance of the new units, MGG will have a fund size of approximately \$2b.

Watermark LIC restructure update

In December 2018 Watermark Funds Management announced the intention to implement schemes of arrangement with the Board of Directors of **Watermark Market Neutral Fund (WMK)** and **Watermark Global Leaders Fund (MGF)** to restructure the LICs to unlisted unit trusts. On 5 March 2019, the Federal Court of Australia authorised each company to convene a shareholder meeting to vote on the proposed restructure. The EGMs for each company will be held on Monday, 8 April 2019.

Both WMK and WGF have each liquidated its investments to cash and will provide a final calculation of the NAVs on 25 March 2019.

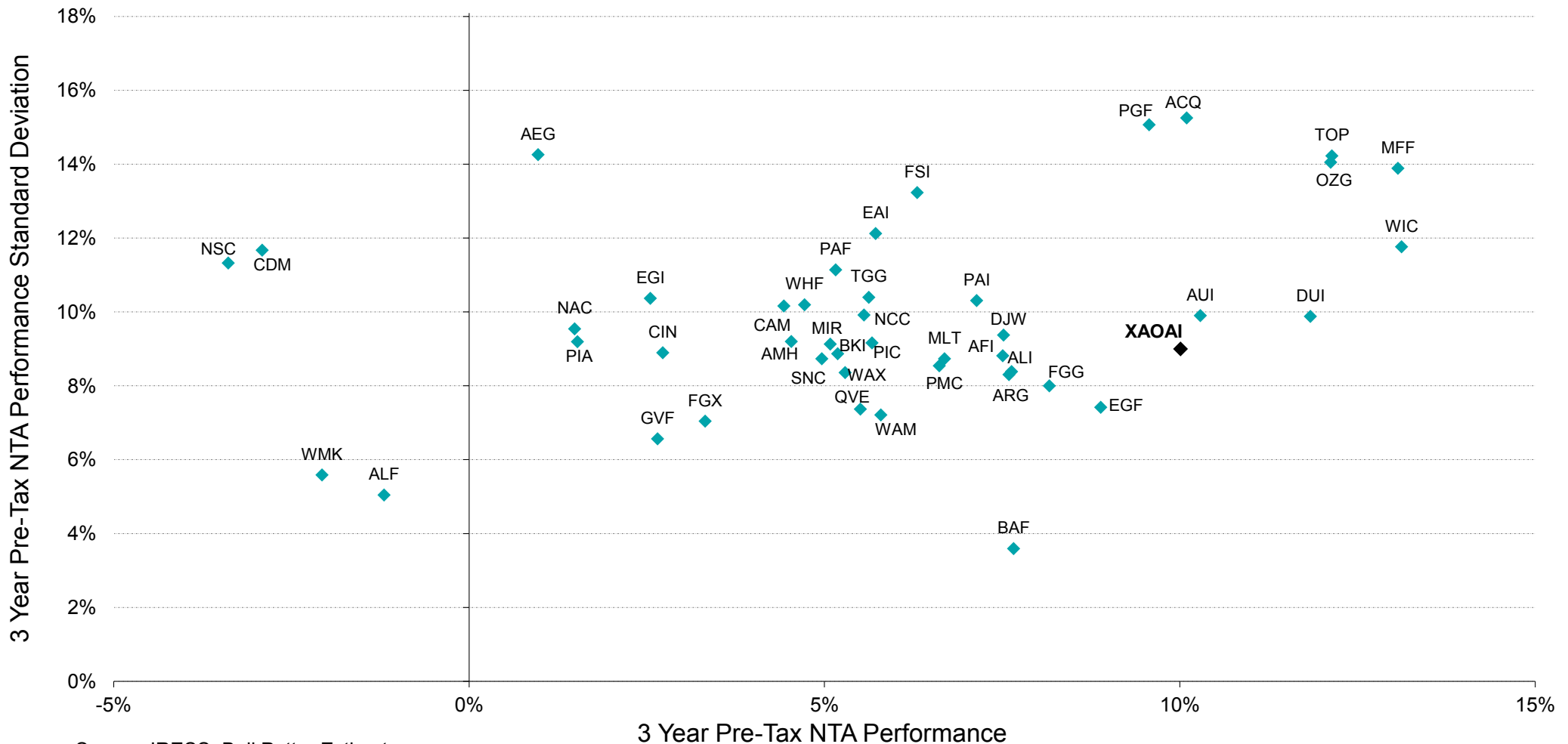

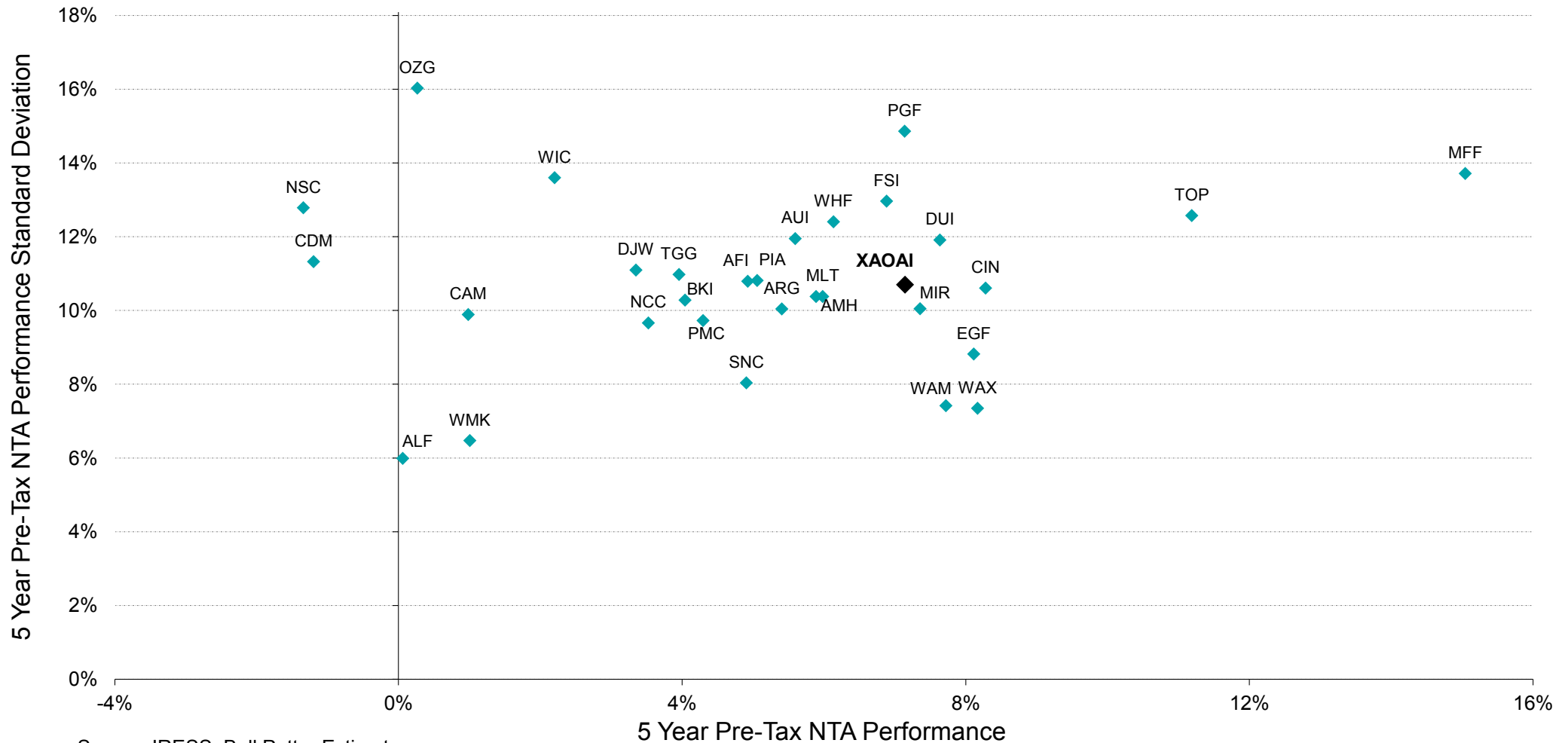
Chart 1: 3 Year Pre-Tax Performance v Standard Deviation

Chart 2: 5 Year Pre-Tax Performance v Standard Deviation

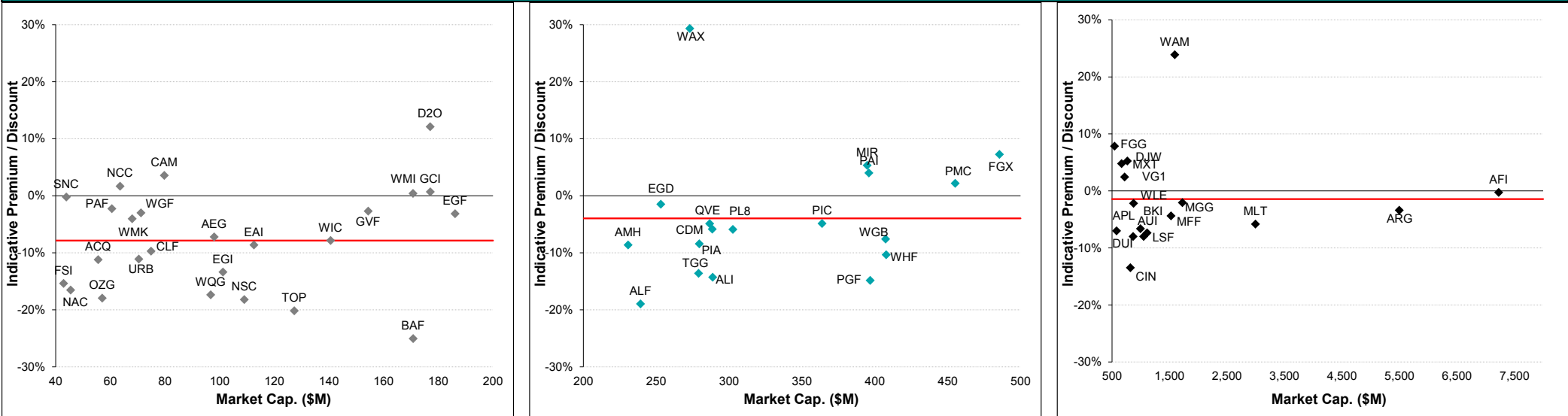

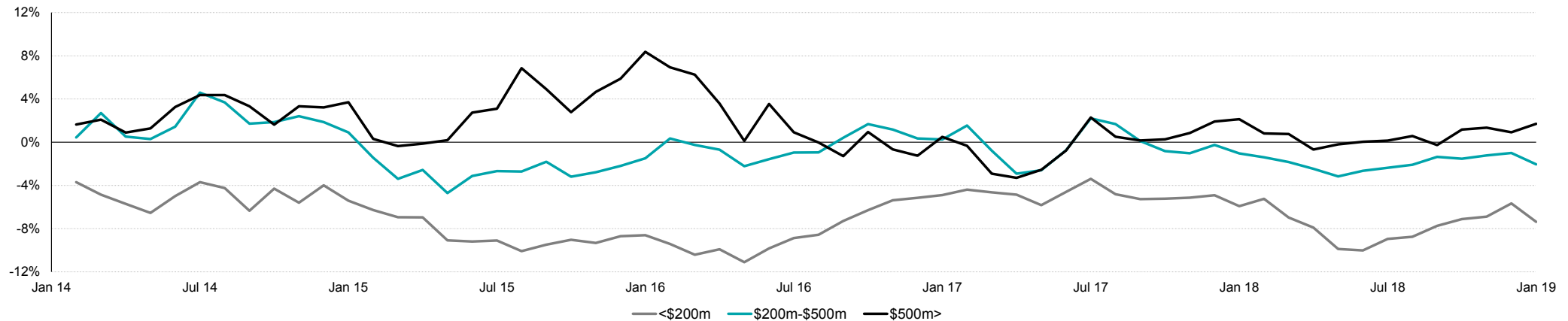

Chart 3: Premium/Discount Relationship Across Market Cap (Equal-Weighted Average Indicated by Red Line)



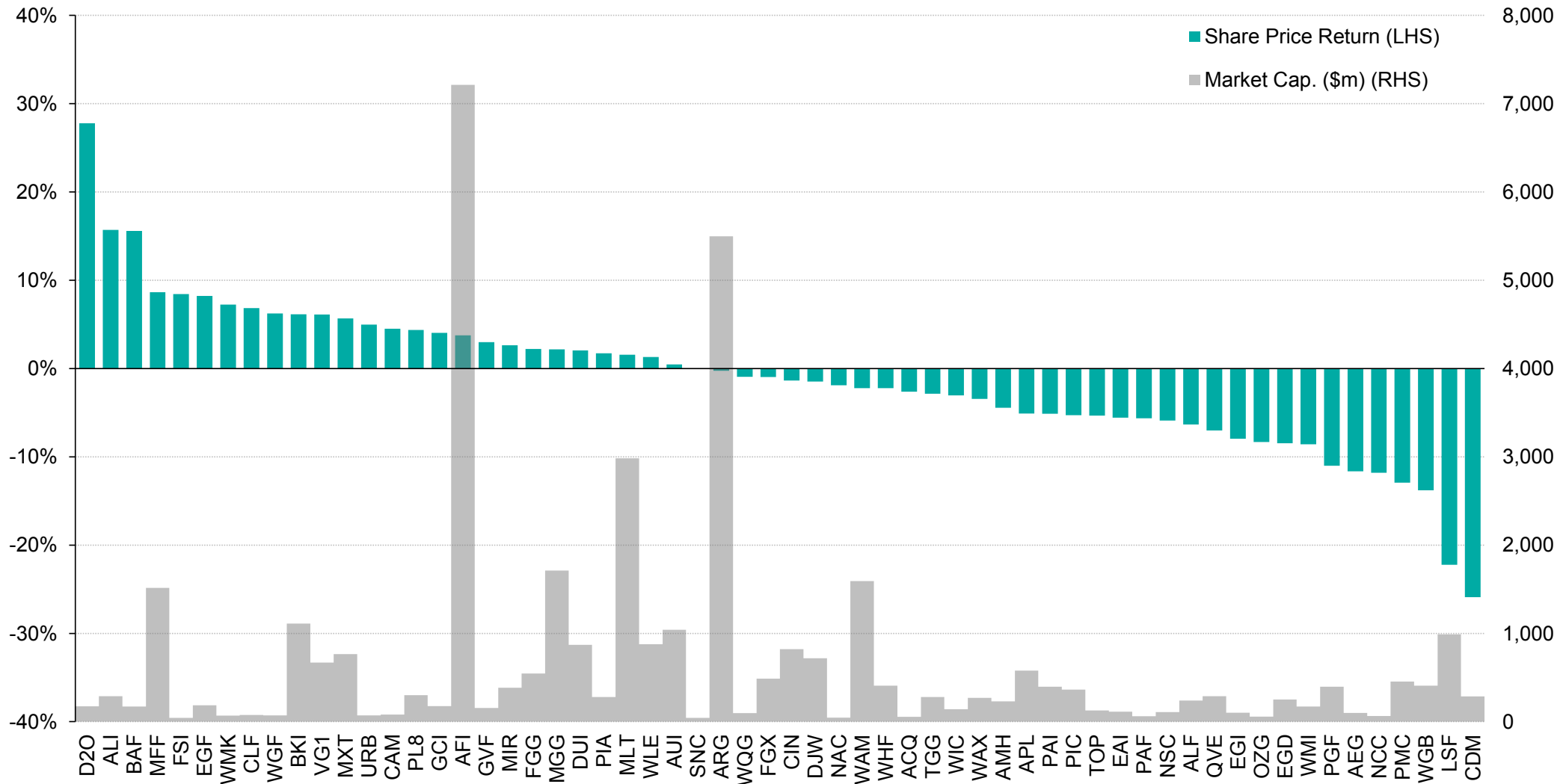
